## The President's Corner

With the start of the fall season, I am sure everyone is anxious to travel to Florida and their winter homes. We look forward to seeing each of you as you arrive in the Sunshine State.

It has been a busy summer at ORO with the daily rain, grass growing and the lawn team trying to keep up, it has been a challenge. With the rain, the weeds have been growing at an accelerated rate. I would like to say the park looks good but with all the weeds that have not been taken care of this summer it does need attention from owners. Remember, as owners, you are responsible to maintain your lots even if you are not in the park.

Some changes you will be hearing about is the discontinuation of the BB&T coupon books for the condo assessments due every quarter. During the past couple of years, we have had several issues with payments being credited to the wrong account, wrong recipient on the coupons, and several small but time-consuming problems. The Florida legislature passed a new law for condo associations effective July 1, 2021, which states that all condo associations must send out an invoice to all owners by either email or paper invoice each quarter. We recently mailed a verification permission form (Consent Form) to you so you may receive your invoice via email. To date we have only received 100 forms back with signatures. We have included this form in this newsletter. Please fill it out and return to the office. It will save us postage cost every quarter. Those of you that have an ACH, you will be informed soon what will need to be done. The good news is that you will now be able to pay your condo assessment via credit card without service fees.

The tree trimming is about 99% done. We are very satisfied with the job performed by Mid Florida! They did a great job cleaning up after trimming trees and removing debris from lots and streets. The services we paid for was explained to us by the arborist. There are four ways to trim palm trees. The first is the hurricane cut which leaves two palm fronds at the very top of the tree like a V. This cut does the most harm to palm trees. The second is the 10 to 2 cut, which is best for the tree (this is the cut we had done) it leaves more fronds than the hurricane cut. The third cut is the 9-3, it leaves many fronds and can be hazardous in a hurricane. The fourth cut should be done every 3 years when they trim the shucks all the way to where they trimmed the fronds. This stops all the debris from the palm tree falling during high winds. We are hoping to have this done next year. The other item we are planning is having Mid Florida provide trimming and health updates to the trees in the common areas of the park. More on this as we develop a plan. If any owner has any question about the type of trimming please email me at president@oro-orlando.com.

We continue to move forward with the 2019 audit. We have a new auditing firm and should have it completed and available for your review by mid-October. The BOD is currently reviewing the draft of that audit. It has taken a long time to get to this point as we have many new procedures in place, records are being corrected and updated. It has been a lot of hard work and I would be remiss if I did not thank the office staff, Park Manager Gail Spence, Temp Accountant Elaine Romero, and Treasurer Teri Gross for their diligence and hard work getting us to this point! The auditor is now working on the 2020 audit and should have that done shortly. I want to thank all owners for your patience during this time. Once the 2020 audit is completed, we plan on having a Town Hall meeting for owners which will give us the opportunity to explain the results of the audits, procedures we have changed, comments from the auditors, total cost to fix the accounting issues and answer any questions you may have. We are hoping to have this meeting in January or early February when many owners are in the park.

In closing, please be safe, wear a mask inside ORO buildings, wash your hands and have a great day!

# **IMPORTANT NOTICE** as of July 1, 2021

Pursuant to Florida Statute Section 718.111 (12)(a)7. Assessment Invoices (also know as "Dues") must now be sent out to all Owners either via the US Post Office or Electronic Transmission (Email). The Statute states that to receive your Invoice via Email, the office must have Written Authorization from the Owner to do so. To receive your Invoice via Email, please sign the enclosed Consent Form (Last page) and return it to the ORO office prior to December 10, 2021.



Pay with your credit card ... ORO doesn't charge Owners **Processing Fees!** 

Condo dues were due on October 1st, 2021.

The fee is \$530 per quarter, per unit.

To avoid a late fee of \$25 your payment must be received by October 15, 2021. If you have any questions please call the office at 863-424-1407.


## Are you ready for some BINGO?



# **Winter Energy Saving Tips**



While owners might not have to contend with snow and ice, when temperatures dip into the 6o's it is chilly by Florida standards. Florida Power & Light Company (FPL), reports, "Weather is the number one cause for high bills. Heating your home is two to three times more expensive than cooling." FPL also reports that people tend to take longer showers in

colder weather, which increases heating costs. While this type of behavior is typical to combat the cold it could make a significant dent into your wallet. Below are some tips from The <u>U.S. Department of Energy</u> (DOE), and FPL on how to keep your home cozy this fall and winter without busting your budget:



### Take advantage of the sun

Keep window shades and curtains open during the day to let the sun heat up your home, then close them in the evening to reduce the chill.

## Cover drafty windows

Install tight fitting shades or insulating drapes around your window.





## Adjust the temperature

When you are home and awake, set your thermostat as low as possible, while still feeling comfortable. When you are asleep or out of the house, turn it back 10-15 degrees for eight hours a day and you can save 10 percent annually. A programmable thermostat makes this an easy task.

#### Water

Turn down the temperature of your water heater to the warm setting, 120 degrees. Try to reduce any lingering in the shower to limit your shower time. Water accounts for 14-25 percent of energy consumption in your home.






## Seal up leaks
